Welcome to our new vendors!!!

Tape/Stickers on items: Please be careful when you put tape or stickers on your items for tags. Sometimes it is extremely difficult to remove and at times it tears the surface of the paper or painted items. You just lost that sale!!!

When you help a customer with a locked case, PLEASE, please take only ONE item out of the case at a time for the customer to look at. When they make a purchase you are to bring the item to the front counter to the staff.

When items such as purses, dressers, trunks, big boxes etc. are purchased, or picked up from layaway, please check them for items that may have made their way inside them. We do have a new form on the back of the SOLD sheet that customers need to fill out before leaving the store.

Do you feel like your sales are slumping? Take a good hard look at your booth and see if it says "STAY OUT!" Sometimes if a booth is too full, or there isn't room to move around in it, customers WILL NOT go in.

With bad weather upon us, we understand that there may be times when you may not be able to get in to the store for your scheduled work time. PLEASE, call us as soon as possible so we can get someone close by to fill in!! Thanks!!!

AAAHHHHH!!! That dang calendar! When TWO of you are working the same shift for the same vendor number, PLEASE sign up in TWO slots! We have had a couple of days with 4 workers in two slots and then no one to sign up in another area. I allow just enough slots for the number of workers I have for the month. When 3 or four people take only two slots it leaves me short on other time slots and we have to pay someone to work fill in. And remember, if you choose not to do your work time, you may pay to have someone work for you. It is \$30 for an eight hour shift.

Please remember that when you are working, don't everyone take a lunch break at the same time. If everyone is eating at the same time it means no one is on the floor!! And another reminder the staff on duty does not need someone at the front with them at all times!! They will call you IF they need help at the till. Vendors working the calendar time need to be on the floor, not hanging around the front.

Check out the store special on rent!!! Rent a new booth for 6 months and get the 7th month free!!

A thirty day written notice is required when you are shrinking down or vacating your booth at the end of the month. This applies when you are leaving after your initial six months OR at any other time after your 6 month commitment is over.
